3. Review & Approval of February 2015 Meeting Minutes

- a. Feb 2015 Meeting Minutes
- b. Senator Todd Moves for approval, Ken Fellman seconds, approved.

4. Fundraising Report: Kate Hawthorne

- a. Updated Fundraising Guidelines sent out with agenda: to be finalized with Fundraising Committee, with support from Scott Nachtrieb.
 - i. Senator Todd Confirmed that the elected officials are not participating in fundraising activities, but that its a shame that she cannot encourage some of the organizations she is involved with to support the CCAB. She thinks it might be a good idea to at least be involved with some of those conversations.

- **ii.** Rep Van Winkle concurred and mentioned that they would not benefit personally in any way, but that they'd like to help the public benefit from the support.
- **iii.** Senator Todd and Tim Ryan: CCAB wants to follow the rules of Amendment 41
- **iv.** Rep Singer: CCAB Did not ask for an opinion from the AG's office, and they might offer other opinions and interpretations.
- v. Ed Krisor stated that the amendment gave exclusive authority to the Ethics Commission to reflect on adherence to the guidelines of Amendment 41. ACTION: Ed Krisor to review
- b. Update on sponsorship opportunities
 - i. Kate has found a new source of leads through Associations Unlimited and is pursuing those leads. 600 new potential sponsors. Following up with Marijuana advocates. 9 other prospects considering sponsorship.
- c. Update on new responses received
 - i. Senator Todd suggests sending links with solicitations. Specifically mentioned all the Chambers, and Kate mentioned learning of 40 new chambers she can pursue.
 - ii. Rep. Van Winkle asked about sponsors highlighted on the homepage, the sponsor page shows 10 sponsors. Action: Fundraising committee needs to determine what to do with former or founding sponsors featured on sponsor's page

5. Switching archive to YouTube - Gavin Dahl

- a. If we use YouTube videos instead of Archive, increase in time for workflow, increase in effort of OMF web team
- b. Download file will need to continue to use Archive
- c. Rep. Van Winkle clarified that he was not suggesting to switch to YouTube completely, use both Archive as YouTube comes through better on cell phones, etc. The goal is to make easier for user.
- d. Tony/OMF clarifies use wouldn't know if they were on archive, or on YouTube.
- e. ACTION: OMF to update the site so that embedded videos are coming from YouTube

6. Colorado Caption Quote Update - Tony Shawcross

- a. Tony received rough quote from Colorado Caption: \$50,000/ year for captioning services
- b. Tony also reached out to YouTube about the anticipated free automated captioning service, has not yet received a response
- c. Come back to this issue before 2016 session
- d. Kate Hawthorne to offer this as a sponsorship option
- e. Senator Todd would like us to continue to explore captioning
- f. Senator Todd requested that we have an end-of-session analytics report on the

- website, and would love to know if we're serving people with different disabilities
- g. Rep. Singer: Joint Technology committee has discussed software options for individuals with visual and audio impairments. There is a Sunset Review Bill on the Colorado Commission on the Deaf and Hard of Hearing. Captioning might be a good solution for them.
- h. Tony clarified that captioning cost is \$84/hour
- Action Item: Gavin Dahl has been asked to try to get a copy of the NAPAN document

- a. Hearing to add Scott Nachtrieb to the Board is Wednesday of this coming week (4/1) and he should be approved by April CCAB meeting
