2. Independent Ethics Commission Ruling - Senator Steadman

Advisory Opinion issued; members who are not actually speaking at the event are not able to receive a free ticket. Members will be charged \$100 to attend. Rep. Benefield has offered to personally ask members to pay and attend this event.

The Advisory Opinion also suggests that it could be "troubling" for members of the legislative body to be asking for donations. Additionally we will need to remove the benefit of sitting with elected members from the sponsorship ask letter.

It is suggested that we drop the event ticket price to \$50. Recorded vote, on whether or not we drop the ticket price to \$50. Motion raised by Sen. Steadman, seconded by John Montgomery.

Motion passes 7 to 2. Ticket price will be reduced to \$50. We will need to change info on website, printed invitations and digital versions of the invites.

Next question is in regards to having the 4 elected officials withdrawal from asking for sponsorships, and just have the remaining board members solicit sponsorships (knowing they have less leverage than the elected officials.) Concerns are expressed in regards to the remaining members having the time and resources to make these asks. Potential solution is that if the elected officials pay their ticket cost (of \$50), then they should be free to make sponsorship asks.

In light of all of the potential repercussions, Rep. Nikkel suggests we cancel this event. This motion is discussed with not many in agreement *initially*. Later a few more board members seem to be in agreement with this idea...

Motion to cancel the Cast of Colorado fundraising event, due to the fact that the ethics committee advisory opinion contains some strong internal inconsistencies (and there is a lack of clarity around what is appropriate for the board to be doing/asking in regards to this event.) The number one priority will remain to add the JBC with any funds collected thru direct asks. Seconded by Sen. Steadman.
